






2. While holding your finger on one side of the module, press on the other side to securely fix it in the bracelet.

The bracelet on the arm should be at a distance of about one finger from the wrist, adjust

Recommendation: if the bracelet is not tightly fixed on the arm, the heart rate sensor data may be inaccurate.

Syncronizing

1. Find the mobile application «Mi Fit» in Mi Store or App Store and download it or scan the QR code.

- a) Main module;
- b) Bracelet;
- c) Charging cable.

Syncronizing

2. Enter the Mi Fit App, open your Mi account and select the bracelet connection function, follow the recommendations, that will appear on the screen. When the bracelet vibrates and the corresponding image appears on the screen, press the bracelet button to complete successful synchronization of the devices.





Using

After connecting, the bracelet begins to capture and analyze your movements, sleep quality and perform other functions. Press the button to turn on the screen.



Swipe your finger up / down to see the details of your movements, check your heart rate and the like.


Swipe up / down to change functions.



Swipe your finger right / left to view various desktops (headings).


Swipe left / right to change the desktops (categories).

Extract the main module



Remove the bracelet from your hand. Hold firmly on both sides, create a small gap between the bracelet and one edge of the main module and gently squeeze it from underneath.

Charging



If the bracelet indicates a low battery level, charge it.

Safety measures

During the measurement of the heart rate, it is not recommended to actively move the hand.

Mi Band 3 bracelet has water protection, which corresponds to the standard 5 ATM, so the device can be used in the shower, pool and others. Do not use the device in the sauna and diving.

Safety measures

The touch button and touch screen do not work in water. The moistened wristband must be wiped with a dry soft cloth or napkin, after which you can continue to use the device. When using the bracelet daily, avoid tightening it too hard on your arm, periodically wipe the wristband with a cloth soaked in a clean water. In case of redness or swelling (or other symptoms) at the point of contact with the bracelet, immediately consult a doctor.
