After switching on the device, display shows a digital value of PM 2.5, an air condition value, displayed by the air quality indicator, can be illuminated with 3 colors.

Connecting to smartphone

Switching Wi-Fi

After the device is on, Wi-Fi icon flashes. If there is no connection for 1 hour, a wireless access point automatically stops, and Wi-Fi icon disappears, if reset button is briefly pressed, a wireless access point is reactivated.

When a mobile device is not connected to the sensor, a short press of reset button allows you to disconnect Wi-Fi connection.

Pressing reset button for a long time turns off the device.

Charging of the device

You can charge the device via USB cable, that connects to the device's charging connector on the back of the device.

After connecting the sensor to power source, the device can also be put on charge.

Note: The MiJia PM-2.5 is not equipped with a USB charging cable, you can use an existing wire of a similar model, or you can purchase it yourself.



A short press of reset button allows you to turn off Wi-Fi.

2. If you find a malfunction of this product, within 8-15 business days from a time you receive the receipt of the product, according to the «List of faults», you can arrive at the MiJia after-sales service center to detect and establish a cause of failure, and exchange the product for free or receive maintenance;

3. If you find a malfunction of this product within 12 months from date of purchase, according to the «List of faults», you can arrive at the MiJia after-sales service center to detect and establish a breakdown pattern and receive free maintenance.

Non-warranty cases

1. Unqualified repair, improper operation, failure due to impact / collision, breakdown due to negligent attitude, abuse, liquid penetration into machinery, failure due to accident, spontaneous modification of the device, improper use of parts of this instrument;

2. In the case of following illegal actions: tearing, falsification of the label of the device, excluding unauthorized access to marking, etc .;

3. If the warranty period has exceeded 3 guarantees (warranty repair, warranty return, guarantee exchange);

4. Damage, caused by force majeure circumstances;

5. Inconsistency of actual malfunction with malfunctions, provided in a «List of faults»;
